## **CAR PARK CARE**

Can I please ask parents to take extra care when dropping off and picking up students from the Bowling Green Lane car park. Greeting our students at the gate each morning I also observe how busy the car park becomes, please be patient, cautious and kind in your vehicles at drop off and pick up time.

## MOBILE PHONES

If your child brings a mobile phone to school please remember to remind your children that they must be handed in to their classroom teacher in the morning and collected from them at the end of the day.

Please also note that this policy also applies to APPLE or SMART Watches that have the capability to make or receive phone calls during school time.

# NOTICE OF ELECTION AND CALL FOR NOMINATIONS FOR MITCHAM PRIMARY SCHOOL COUNCIL IN 2021

The School Council is composed of parents, teachers and the Principal. All school councils in Victoria operate under the Education and Training Reform Act 2006. Each school council is established by an Order of the Minister for Education, which specifies the council's membership, size and configuration, its objectives, powers, functions and accountabilities and the role of its executive officer who is the principal.

## FROM THE PRINCIPAL'S DESK: CONTINUED

School councils have three main responsibilities:

- Finance overseeing the development of the school's annual budget and ensuring proper records are kept of the school's financial operation.
- Strategic Planning participating in the development and monitoring of the school strategic plan.
- Policy Development and Review developing, reviewing and updating policies that reflect a school's values and support the school's broad direction outlined in its strategic plan.

The MPS School Council Meetings are usually held on the second Tuesday of the month and the final meeting of the 2020 Council will be held in the Staff Room at 7:00 pm on Tuesday, February 9th.

All School Council members are appointed for two years and then the positions become vacant at the conclusion of each member's two year appointment. This year there are three elected parent member vacancies and one DET (staff) position open for election.

I would like to take this opportunity to also acknowledge the 2020 School Council members for their contribution to the School Council and sincerely thank them for their time, effort and dedication to Mitcham PS. The school is noted for its community feel staff member vacancy and the work by this group of people has ensured that this reputation continues. We are extremely grateful to them.

The timeline for the school council election is printed below. Nomination forms will be available from the office from, Tuesday 9th February.

All government schools in Victoria have a School Council. They have legally formed bodies that are given powers to set the key directions of the school within centrally provided guidelines.

## Functions of a school council:

The functions of a school council are outlined in the Education and Training Reform Act 2006 and include:

- establishing the broad direction and vision of the school within the school's community
- participating in the development and monitoring of the school strategic plan
- approving the annual budget and monitoring expenditure
- developing, reviewing and updating school policies
- raising funds for school-related purposes
- maintaining the school's grounds and facilities
- entering into contracts (such as for cleaning or construction work)
- reporting annually to the school community and to the Department
- creating interest in the school in the wider community
- informing itself of and taking into account the views of the community
- regulating and facilitating the after-hours use of school premises and grounds
- operating a children's service at the school or other premises controlled by the Minister.

One of the reasons for our school's success is that we have enjoyed great support from elected parents who offer their assistance in the areas listed above to the school administration and staff. We want this to continue and are looking for supportive parents to nominate for School Council.

## **CSEF (CAMPS & SCHOOL EXCUSRIONS FUND)**

The Camps, Sports and Excursions Fund (CSEF) provides payments for eligible students to attend activities like:

- School camps or trips
- school-organised Swimming and sport programs
- Outdoor education programs
- Excursions and incursions.

Applications for 2021 are now open and will close at the end of Term 2. Families holding a valid means-tested concession card or temporary foster parents are eligible to apply.

Successful applicants will receive \$125 per year for eligible primary school students. Payments are made directly to the school and are tied to the individual student. Most payments start from March onwards.

Payments are for the application year and cannot be claimed for previous years.

The CSEF payment cannot be used towards voluntary school charges, books, stationery, school uniforms, before/after school care, music lessons, or formals/graduations.

You will only need to submit an application form in 2021 if any of the following changes have occurred:

- Your child has started or changed schools in 2021 or you did not apply at the same school in a previous year
- Changed family circumstances: such as a change of custody, change of name, concession card number, or new siblings commencing at the school in 2021.

We are able to accept and process applications up until the end of term two each year.

The payment system only allows one application per student. Parents in shared custody situations (who both hold a concession card) must make the decision beforehand who applies for the CSEF at the school on behalf of their children.

If you have already paid for some camp, sports or excursion costs up front, you have the option to

- Allocate the payment towards remaining activities in 2020
- Carry over the amount to be used on eligible activities in 2021

Please note. CSEF funds cannot be directly refunded to families.

If you think you may be eligible, and are yet to apply, or would like more information, please see the information and application sheets enclosed in the later pages of this newsletter. Alternatively, contact our school office for more information.

## **CENTREPAY**

Centrepay is a free bill paying service that allows applicable families to pay bills and other costs, direct from their Centrelink payments.

Using Centrepay vou arrange regular can deductions from your Centrelink payment. You can start, change, or stop using Centrepay whenever you like. You can use it for your regular bills and other ongoing expenses, such as rent, electricity, phone and school fees.

We are located next to the tennis court. We look forward to meeting and getting to know you all.

## **VACATION CARE RECAP**

Our vacation program was full of fun and engaging themes, including several incursions such as Australian Reptiles, Build a Bear workshop, and an exciting magic show. Children particularly enjoyed the science theme, where they conducted various science experiments and built many things using our recycled materials.

## **PREP STUDENTS**

During the early dismissal of the Prep classes, we will be providing bridging care which means we will be open from 1:25 pm. All the Preps will be picked up from their classes in the afternoon and dropped to their classes in the morning when attending the OSH Club.

This week our theme was welcoming our Preps, as well as new students, and understanding our routine and expectations. Our main focus was assigning buddies to the Preps and taking them through OSHClub boundaries and routine. A courtesy phone call, voicemail or text will be highly appreciated and allow our team to focus on the children in attendance.

We are in the process of updating our medical records. Please set aside a few minutes when picking up your child in case we need you to go through our records. Also, if your child/ren is scheduled to attend any after school activities, please let us know so that we can cater to their needs and have permission forms ready to sign.

#### **BEING SUNSMART**

A kind reminder that we are following our Sun Smart policy according to UV level index. So, please remember to provide a hat for your child. We supply Coles' branded 50+ protection sunscreen here at the service, however, if your child has specific sunscreen needs, we encourage parents to either leave some with us at the program or ensure that children have some in their bags.

## **COVID-19 PROCEDURES**

We are constantly monitoring the children's hand washing routine. We have reiterated to the children that they must wash their hands for 20 seconds or more. Some ways we have suggested this to them is by siing the alphabet or singing the happy birthday song while washing hands. ## **BOOKING POLICY FOR BSC AND ASC SESSIONS**

Parents will not be able to book in within 24 hours of a session as the booking system is locked 24 hours before the sessions commencement time.

Parents can book or cancel their child's attendance on the day by calling or texting 0422 097 497.

Program times are from 7.00am—9.00am and 2:30pm—6:30pm, bookings will be confirmed during these times. A late booking fee of \$4 will automatically be charged when a booking is made at short notice (0-24 hrs ahead of the start time of the session).

When a child is booked into a session, but does not attend, and there has been no notification that they will be absent, a \$5 'no-show' fee will be incurred. A 'no show' creates additional work for the educators as they must confirm whether a child is legitimately absent.

Our cancellation policy is 48 hours before the session commences. Cancellations within 48 hours will incur full fee.



## FINANCIAL ASSISTANCE

## INFORMATION FOR PARENTS

Every Victorian child should have access to the world of learning opportunities that exist beyond the classroom. The Camps, Sports and Excursions Fund helps ensure that no student will miss out on the opportunity to join their classmates for important, educational and fun activities. It is part of making Victoria the Education State and the Government's commitment to breaking the link between a student's background and their outcomes.

# CAMPS, SPORTS & EXCURSIONS FUND (CSEF)

School camps provide children with inspiring experiences in the great outdoors, excursions encourage a deeper understanding of how the world works and sports teach teamwork, discipline and leadership. All are part of a healthy curriculum.

CSEF is provided by the Victorian Government to assist eligible families to cover the costs of school trips, camps and sporting activities.

If you hold a valid means-tested concession card or are a temporary foster parent, you may be eligible for CSEF. A special consideration category also exists for asylum seeker and refugee families. The allowance is paid to the school to use towards expenses relating to camps, excursions or sporting activities for the benefit of your child.

The annual CSEF amount per student is:

- · \$125 for primary school students
- · \$225 for secondary school students

#### **HOW TO APPLY**


New applicants should contact the school office to obtain a CSEF application form or download from www.education.vic.gov.au/csef

If you applied for the CSEF at your child's school in 2019, you do not need to complete an application form in 2020 unless there has been a change in your family circumstances.

You only need to complete an application form if any of the following changes have occurred:

- new student enrolments; your child has started or changed schools in 2020 or you did not apply in 2019.
- changed family circumstances; such as a change of custody, change of name, concession card number, or new siblings commencing at the school in 2020.

Check with the school office if you are unsure.

## **CSEF ELIGIBILITY**

Below is the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

#### Criteria 1 - Eligibility

To be eligible\* for the fund, a parent or legal guardian of a student attending a registered Government or nongovernment Victorian primary or secondary school must:

- · on the first day of Term one, or;
- · on the first day of Term two;
  - a) Be an eligible beneficiary within the meaning of the State Concessions Act 2004, that is, be a holder of Veterans
    Affairs Gold Card or be an eligible Centrelink Health Care Card (HCC) or Pensioner Concession Card (PCC)
    holder, OR
  - b) Be a temporary foster parent, and;
  - c) Submit an application to the school by the due date.
- \* A special consideration eligibility category also exists. For more information, see: <u>Camps, Sports and Excursions Fund</u> (education.vic.gov.au)

Parents who receive a Carer Allowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with one of (a) or (b) above.

#### Criteria 2 - Be of school age and attend school in Victoria

School is compulsory for all Victorian children aged between six and 17 years of age inclusive.

For the purposes of CSEF, students may be eligible for assistance if they attend a Victorian registered primary or secondary school. Typically, these students are aged between five and 18 years inclusive.

CSEF is not payable to students attending pre-school, kindergarten, home schooled, or TAFE.

## **Eligibility Date**

For concession card holders CSEF eligibility will be subject to the parent/legal guardian's concession card being successfully validated with Centrelink on the first day of either term one (27 January 2021) or term two (19 April 2021).

## **PAYMENT AMOUNTS**

#### CSEF payment amount

The CSEF is an annual payment to the school to be used towards camps, sports and/or excursion expenses for the benefit of the eligible student.

- Primary school student rate: \$125 per year.
- Secondary school student rate: \$225 per year.

The CSEF is paid directly to your child's school and will be allocated by the school towards camps, sports and/or excursion costs for your child.

For ungraded students, the rate payable is determined by the student's date of birth. For more information, see: <u>Camps, Sports and Excursions Fund (education.vic.gov.au)</u>

Year 7 government school students who are CSEF recipients are also eligible for a uniform voucher. Secondary schools are required to make applications on behalf of parents so please register your interest at the school.

## HOW TO COMPLETE THE APPLICATION FORM

## NOTE: ALL SECTIONS MUST BE COMPLETED BY PARENT/LEGAL GUARDIAN

- 1. Complete the PARENT/LEGAL GUARDIAN DETAILS section.
  - Make sure that the Surname, First Name, and Customer Reference Number (CRN) details match those on your concession card. You will also need to provide your concession card to the school.
  - If you are claiming as a Foster Parent or a Veteran Affairs Pensioner, you will need to provide a copy of documentation confirming your status as a temporary Foster Parent or provide your Veterans Affairs Pensioner Gold card to the school.
- 2. Complete the STUDENT/S DETAILS section for students at this school.
- 3. Sign and date the form and return it to the school office as soon as possible. The CSEF program for 2021 closes on 25 June, 2021.

CSEF payments cannot be claimed retrospectively for prior years.
